# **Training Overview**

IFS is a leading model of psychotherapy developed by Dr. Richard C. Schwartz. It offers a non-pathologizing and empowering view of people and is used worldwide. The IFS Level 1 Training provides a comprehensive introduction to the theory and techniques of the IFS model. It also invites participants to explore their own inner world in a safe and supportive environment.

# Participation & Certification

#### **Participation**

- Upon completion of the training, you will receive a certificate of participation from the international IFS Institute (requirement: attendance of at least 75 out of 89.5 training hours).
- This certificate allows you to integrate the IFS model into your therapeutic work.
- It also qualifies you to apply for:
  - Advanced IFS trainings (e.g., Level 2, Level 3)
  - Programs recognized by the international IFS Institute
  - Serving as a Program Assistant
     (PA) in future trainings

#### Certification

- Important: Participation in a training does not mean that you are automatically certified.
- To become a certified IFS Therapist or IFS Practitioner, you must complete a separate <u>certification</u> <u>process</u> with the international IFS Institute (IFSI).
- Accreditation with the relevant Chamber of Psychotherapists: 142 points (Germany)



### **Admission Criteria**

The Level 1 Training is intended for professionals in the field of mental health. Admission is based on the criteria of the international IFS Institute, adapted for the German-speaking context. The three main admission criteria are:

- Membership in a professional association relevant to your therapeutic work.
- Training in a psychotherapeutic method
  You have already completed training in a
  psychotherapeutic approach.
- License to treat individuals with mental health conditions

You are authorized to treat people with psychological disorders – for example, as a psychiatrist, licensed psychological psychotherapist, child and adolescent psychotherapist, physician, alternative practitioner for psychotherapy ("Heilpraktiker:in"), or psychiatric mental health nurse.

#### Also eligible – without a license to treat

The following qualifications also meet the admission requirements:

- Social workers or social pedagogues with a master's degree who work in a clinical or psychological setting
- Art therapists and social education assistants working in a clinical or psychological setting
- Systemic child and youth therapists, systemic couples and family therapists, and clinical addiction counselors with a master's degree
- Individuals with a master's or doctoral degree in the field of mental health whose research focuses on IFS



# **Application Process**

#### Your application

- You can apply for the IFS Level 1 Training from October 1 to November 12, 2025 (application period: 6 weeks). After the deadline, you may apply as a potential waitlist candidate.
- Please fill out our application form.
- All applicants will receive a response no later than two weeks after the application deadline.

#### **Admission Criteria**

- You meet the admission criteria
- Diversity: We aim to create participant groups that are as diverse as possible.
- Applications are welcome from all regions, though priority is given to applicants from German-speaking countries.



### **Investment & Conditions**

#### Investment

- The Level 1 Training costs €4,550 (VAT-exempt).
- The training manual as well as beverages and snacks during the first in-person module are included.
- Additional individual costs may arise for travel, accommodation, and main meals.

#### **Payment Terms**

- You can secure your spot with a deposit of €750, due 14 days after receiving the invoice.
- The remaining balance (€3,800) is due by June 1, 2026.
- All other individual expenses must be paid directly to the respective service providers.


#### **Legal Information**
