# **Training Overview**

IFS is a leading model of psychotherapy developed by Dr. Richard C. Schwartz. It offers a non-pathologizing, empowering view of humans and is used worldwide. The IFS Level 1 training provides a comprehensive introduction to the theory and techniques of the IFS model. It also invites participants to explore their own inner world in a safe and supportive environment.

- All applicants will receive feedback by March 1, 2025
- Applicants who do not receive confirmation will automatically be placed on a waiting list

#### **Selection Criteria**


- You hold one of the specified professional qualifications (see target group)
- We can accommodate up to 10 participants from neighboring countries within the DACH region
- Diversity: We strive to make our participant groups as diverse as possible

If you reside in Germany, Austria, Switzerland, or in a neighboring country without an IFS partner institute, we encourage you to apply.

# Participation & Certification

### **Participation**

- At the end of the training you will receive a certificate of participation from the international IFS Institute (prerequisite: participation in at least 75 of the 89.5 training hours)
- You can then work as an IFS therapist
- The certificate of attendance allows you to attend Level 2 training and other official programs
- The certificate of attendance is also a prerequisite for applying as a Program Assistant (PA) worldwide

#### Certification

- Please note that admission to a training does not imply that the requirements for IFS certification have been met
- If you would like to become a certified IFS therapist, you will need to complete the certification process through the IFS Institute (IFSI). - Level 1 is accredited by the Bavarian and Rhineland-Palatinate Chambers of Psychotherapists (111 points)

- All other individual costs are to be paid directly to the respective service providers


